

Information and Application Instructions

As a service to the legal profession, ALI CLE makes a limited number of full and partial scholarships available for ALI CLE's live courses, webcasts, and online CLE (on-demand web courses). Qualifying attorneys will be notified by email if their application is approved and will receive scholarships of at least:

- Live In-person programs - 30% tuition reduction. No reimbursement for other out of pocket expenses (travel etc.)
- Webcast programs - 30% tuition reduction
- On-demand (recorded programs) - 50% tuition reduction

A limited number of larger scholarships (including full scholarships) may be available for select programs. Preference will be given to attorneys who seek to learn skills used for *pro bono* activities and those with financial hardship. Attorneys licensed for five years or less, or who are full-time employees of federal, state, or local governments automatically qualify for a tuition reduction of 20% with no application required. Please contact customer service for more information.

Who should apply?

Judges; judicial law clerks; law professors; law students; retired attorneys 65 or older; law librarians; attorneys licensed fewer than five years; attorneys who work for nonprofit organizations, legal services organizations, or government agencies; and unemployed attorneys all are encouraged to apply. Attorneys in private practice who are in need and who seek to learn skills that will assist them in *pro bono* activities also are encouraged to apply.

How do I apply?

Please fill out the attached application form and return it with a copy of your student ID, if applicable. Applications for live courses on-site should be submitted at least four weeks before the start date. Applications for live webcasts should be submitted at least two weeks before the scheduled date. Full scholarships for live programs can not be granted more than once in a 3 year period.

When will I be notified?

Applicants for scholarships for a live course will receive registration acknowledgment via email within three weeks of the start of the course. Applicants for scholarships for a live webcast will be notified within one week of the start of the course.
